Decreased sex drive and **erectile dysfunction** have also been reported (which in some cases continued after treatment was stopped).

If you experience any side effects, including those not listed in the leaflet, speak to your doctor or pharmacist or report directly to the Yellow Card scheme (www.mhra.gov.uk/yellowcard).

Finasteride and dutasteride - Updated safety warnings for psychiatric side effects and sexual dysfunction

Medicines UK, on behalf of the following Marketing Authorisation Holders (MAHs) for finasteride and dutasteride containing medicines, is distributing this DHPC letter in agreement with the Medicines and Healthcare products Regulatory Agency (MHRA) to all Healthcare Professionals that prescribe or dispense these medicines to inform you of the following:

With regards to GPs and pharmacists, in line with the MHRA agreed distribution plan for this letter, this has been issued to one named GP or pharmacist within the practice/pharmacy. **Please ensure that this important information is disseminated to all GPs/HCPs/Pharmacists** in the practice/pharmacy who are likely to be involved in treating or dispensing to patients with finasteride or dutasteride.

Summary of the safety concern:

- **Suicidal ideation is an adverse reaction of oral finasteride-containing products, mainly reported in patients treated for androgenetic alopecia.**
- **Advise patients treated with oral finasteride for androgenetic alopecia to stop treatment and seek medical advice if they experience depressed mood, depression or suicidal ideation.**
- **Sexual dysfunction that may contribute to mood alterations, including suicidal ideation, has been reported in some patients treated for androgenetic alopecia. Sexual dysfunction may also occur without mood alterations. Inform patients to seek medical advice in case of experiencing sexual dysfunction and consider discontinuation of treatment.**
- **A Patient Alert Card is available in the package of medicinal products containing finasteride to highlight the risks of depressed mood, depression, suicidal ideation and sexual dysfunction reported with finasteride.**
- **Despite the insufficient evidence to establish a direct association of suicidal ideation with dutasteride, based on the common mechanism of action for medicinal products of the class of 5-alpha reductase inhibitors, patients treated with dutasteride should be recommended to seek prompt medical advice if symptoms of mood alterations occur.**

Background on the safety concern

Finasteride and dutasteride are 5-alpha-reductase inhibitors (5-ARis). Finasteride is an inhibitor of the enzyme 5-alpha-reductase types 1 and 2 with a greater affinity for type 2. Dutasteride targets both isoforms of this enzyme.

Lower dose oral formulations of finasteride (1 mg) are indicated for the treatment of male pattern hair loss (androgenetic alopecia). Higher dose oral formulations of finasteride (5 mg) are indicated for the symptomatic treatment of benign prostatic hyperplasia and for the reduction of urologic events. Dutasteride is available as an oral formulation, including in combination with tamsulosin, and is indicated for the management of symptomatic benign prostatic hyperplasia. For finasteride and dutasteride containing medicinal products, some psychiatric side effects are already reflected in the product information.

Following a review by the MHRA of the available data regarding suicidal ideation and behaviours reported with 5-ARIs, it was concluded that the level of evidence for these events differs according to the respective indications, active substances and formulations.

Within the review, 170 reports of suicidal ideation have been identified in MHRA Yellow Card database of suspected adverse drug reactions and 5 reports for dutasteride up to 31 May 2025. Most of the cases were reported for patients treated for alopecia, although not all reports contain the dose or indication. Prescribing data suggests more than 400,000 prescriptions per month are issued for finasteride 5mg and dutasteride containing medicines. As finasteride 1mg is not prescribed on the NHS and is only available by private prescription, accurate prescription numbers are not available.

Finasteride 1 mg (androgenetic alopecia)

Following the review of the available data, the MHRA confirms that suicidal ideation is an adverse drug reaction with the frequency not known, meaning that it cannot be estimated from the available data. The current product information of these formulations already contains a warning on mood alterations including suicidal ideation, together with a recommendation to stop treatment and seek prompt medical advice if these symptoms occur. In addition, the review identified cases of suicidal ideation and sexual dysfunction (a known adverse drug reaction of finasteride) which may have contributed to the development of mood alterations, including suicidal ideation. Warnings and precautions for use will be updated to advise patients to consult their doctor if they experience sexual dysfunction, and discontinuation of the treatment should be considered.

A Patient Alert Card is included in the package to inform about the risks of mood alterations, including suicidal ideation, and of sexual dysfunction and to advise on the appropriate actions to be taken.

Finasteride 5 mg (benign prostatic hyperplasia)

The review also confirmed that suicidal ideation is an adverse drug reaction with the frequency not known (cannot be estimated from the available data). The current product information of these formulations already contains a warning on mood alterations, including suicidal ideation, together with the recommendation to seek prompt medical advice if these symptoms occur.

A Patient Alert Card is included in the package to inform about the risks of mood alterations, including suicidal ideation, and of sexual dysfunction and to advise on the appropriate actions to be taken.

Dutasteride 0.5 mg (benign prostatic hyperplasia) including combinations with tamsulosin

Although there is insufficient evidence to establish a risk of suicidal ideation with dutasteride, as a precautionary measure, and based on the evidence for another oral 5-Ari (finasteride), warnings and precautions for use will be updated to inform about the potential risk of suicidal ideation, with a recommendation that patients should seek prompt medical advice if symptoms of mood alterations occur.

Call for reporting

Please continue to report suspected adverse drug reactions (ADRs) to the MHRA through the Yellow Card scheme.

Please report:

- all suspected ADRs that are serious or result in harm. Serious reactions are those that are fatal, life-threatening, disabling or incapacitating, those that cause a congenital abnormality or result in hospitalisation, and those that are considered medically significant for any other reason
- all suspected ADRs associated with new drugs and vaccines identified by the black triangle ▼
